Please label your artwork on back with name, title, media & price. All artwork must be properly framed and ready to hang with wire on back – no sawtooth hangers. VECCA reserves the right to refuse any artwork deemed inappropriate, i.e., improperly framed, obvious copyright infringement, etc.

COMMISSION: 20% commission will be taken by VECCA on all works sold. Price your work accordingly.

PICK-UP DATE: Friday, on the ending date of the show, **10am - 12noon** at the Shenandoah County Govt. Bldg.
